



Notes below emailed after the event :	
Broad Street or High Street Why not make one of these streets' pedestrian only, with access only for loading/unloading? This could be combined with the planting of trees either side of the road. This latter element would make the town so much more attractive; like Llanidloes is. There would be a loss of on- street parking but I think it would be worth the hit as there is plenty of off-street parking for the town. The trees planted would need to be fairly well-established ones but the recent introduction of CCTV should limit the vandalism.	
Severn Square - This is one of the most attractive, if small! parts of the town, apart from the garage frontage. Christmas lights on the trees there would look great. Also, could the garage owners be helped to access any grant to help them restore what could be an iconic building. A similar garage in Llandrindod is currently being restored.	
Photography competition Why not run a photography competition for the best photographs taken in the town centre? A modest prize could give you access to the use of some good imagery – you'd need to put something in the Ts and Cs that you can use the imagery to promote the town, though.	
Bypass I know it's the WG's responsibility but could you work with them to sow wildflower seed on the banks of the road?	
Theatr Hafren flytower. This has been in a state of disrepair for at least two years now. Could the TC put pressure on the theatre to improve it? It makes that entrance to the town look shoddy.	
A cycling sportive. There are many companies which are organising cycling sportives but, as far as I'm aware there are few in mid Wales. Newtown, as a start and finish, would attract visitors to the town. I think it would just be a case of seeing if there is any interest from one of the sportive companies. Hafren Cycling Club would be able to advise.	

Fencing around Mochdre Industrial Estate Could the TC work with whoever the owners of the industrial estate at Mochdre to remove the wooden fencing bordering the roundabout and the nearby roads? The fence doesn't achieve anything other than attract flypost adverts which are usually left there for years on end.

Email sent after the event:

One of the main concerns with our town is the preservation of open spaces. It is very welcome that the Dolerw park has finally a plan for its regeneration and management. For too long this town asset has not been under utilised.

We live in Oaklands Park, at the top of Barnfields, and we do have some open undeveloped spaces left here. Oaklands Park has two play areas/ kick abouts which we hope will remain that way. A few years ago there was the threat from the developer to build on these last two open spaces. There is also a large field behind Oaklands Park which we have always been informed would not be developed. This is a haven for wildlife and an open space where residents can walk and enjoy nature. There has recently been some grass cutting activity (first time in 13 years) which we hope does not indicate any changes to come. Development of this land would create more traffic issues for Barnfields especially during any construction phase.

May I also comment about the once proposed pedestrianisation of Broad street. If this street was indeed made traffic free, it would enhance the product offered in town. We need a free safe space where businesses could expand their offering and events could be organised by various charities and NGO's. Now that the bypass is in place, diverting traffic away from Broad street should not create many issues.

Newtown needs to keep itself alive by offering something different to attract more people into town.
